I thereby waive, release and discharge for myself, my heirs, executors, and successors in interest (hereafter, collectively "successors") any and all rights and claims which I have, or which may hereafter accrue to me, against the Wakita Lion's Club or any officer, member, or sponsor thereof. I agree for myself and successors that the above representations are contractually binding and are not mere recitals, and that should I or my successors assert any claim in connection with this agreement, I or my successors shall be liable for the expenses including attorney fees incurring by the Wakita Lion's Club or an officer, member, or sponsor thereof. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as consent to any other provision herein or as consent to any subsequent waiver modifications.
